



# Mobile End User License Agreement

## First Technology Federal Credit Union Terms of Use - End User License Agreement

THIS IS A LEGAL AGREEMENT BETWEEN YOU AND First Technology Federal Credit Union.

("FTFCU") for use in the United States, stating the terms that govern your use of the First Tech Mobile application ("Licensed Application"). This agreement, together with all updates, additional terms, additional mobile product agreements, software licenses, and all of FTFCU's rules and policies, collectively constitute the "agreement" between you and FTFCU. By installing the Licensed Application you are indicating that you agree to these terms. If you do not agree to these terms do not install or use the application. You must accept and abide by these terms as presented to you. Changes, additions, or deletions are not acceptable, and FTFCU may refuse access to the Licensed Application for noncompliance with any part of this agreement.

The Licensed Application is licensed, not sold, to you for use only under the terms of this license, unless accompanied by a separate license agreement issued by FTFCU, in which case the terms of that separate FTFCU license agreement will govern. Licensor ( hereinafter, "Licensor" or "FTFCU") reserves all rights not expressly granted to you.

This license granted to you for the Licensed Application by FTFCU is limited to a non-transferable license to use the Licensed Application on your IOS iPhone, iPad iPod Touch, Android, or Windows devices that you own or control and as permitted by the Usage Rules set forth in Section 9.b. of the App Store Terms and Conditions (the "Usage Rules"). This license does not allow you to use the Licensed Application on any product that you do not own or control, and you may not distribute or make the Licensed Application available over a network where it could be used by multiple devices at the same time. You may not transfer in any form (including rent, lease, lend, sell, redistribute, or sublicense) the Licensed Application. You may not copy (except as expressly permitted by this license and the Usage Rules), decompile, reverse engineer, disassemble, attempt to derive the source code of, modify, or create derivative works of the Licensed Application, any updates, or any parts of updates, except regarding use of open source elements components included with this Licensed Application). The license is effective until terminated by you or FTFCU. Any rights granted herein are subject to termination with or without notice from FTFCU if you violate and/or fail to comply with any terms or conditions set for herein. Once this license is terminated, you are no longer entitled to use the Licensed Application. You shall cease all use of the Licensed Application, and destroy any legally made copies or portions thereof, of the Licensed Application.

The Licensed Application may enable access to FTFCU and third party services and web sites, including GPS locator websites, such as Google, that allow you to find a branch (collectively and individually, "Services"). Use of the Services may require Internet access and that You accept additional terms of service.

To the extent this Licensed Application allows you to access third party Services, FTFCU, and its licensors, reserve the right to change, suspend, remove, or disable access to any Services at any time without notice. In no event will FTFCU be liable for the removal of or disabling of access to any such Services.
