

**OFFICIAL RULES
FIRST TECH SECOND CHANCE SWEEPSTAKES**

- 1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. VOID WHERE PROHIBITED.**
- 2. ELIGIBILITY.** The First Tech Second Chance Sweepstakes (the “Sweepstakes”) is open to persons 18 years of age or older at the time of entry who are legal residents of the 50 United States and District of Columbia, except employees (former and current) of First Technology Federal Credit Union (“First Tech”, “Sponsor”), Foote Sports Productions, Inc., (“Administrator”) and each of their respective affiliated companies, subsidiaries, and advertising or promotional agencies, and the family members, agents, successors or assigns of, and any persons domiciled with, such employees, are not eligible for entry. No social media platform on which this Sweepstakes is promoted is a sponsor, administrator, prize fulfillment company, is in any way connected with this Sweepstakes.
- 3. ENTRY.** The Sweepstakes will begin on April 18, 2025 and will end at 11:59 p.m. Pacific Time (“PT”) on May 7, 2025 (the “Entry Period”). To enter the Sweepstakes, go to <https://www.firsttechfed.com/htc25> and enter your name and valid email address, along with other information requested. **LIMIT OF ONE (1) ENTRY PER PERSON.** In the event of a dispute, all electronic entries will be deemed to have been submitted by the owner of the electronic account from which they were sent. For these purposes, an account holder shall mean the natural person assigned to such electronic account by the Internet access provider, online service provider or other organization responsible for assigning such electronic account. Any questions regarding the owner of an electronic account shall be determined by Sponsor in its sole, reasonable discretion. Sponsor will not be responsible for incomplete, lost, late, misdirected or illegible entries, or for failure to receive entries for any reason, any of the equipment or programming associated with or utilized for an entry, or by any technical or human error that may occur due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with entrant or Sponsor. Entrants must fully complete the online entry form. All incomplete or inaccurate entries are void. Online form entry entrants are given the opportunity to allow their personal information to be shared with Sponsor to receive commercial emails, however eligibility to participate in the Sweepstakes does not depend upon entrant consenting to continue to receive these emails, nor does consenting to receive these emails impact any entrant’s chance of winning.
- 4. DRAWING.** On or about May 8, 2025, one (1) potential winner will be chosen by random drawing from all eligible entries received during the Entry Period after confirmation of eligibility and verification by Sponsor,
- 5. PRIZE.** The confirmed winner will receive one team entry into the 2025 Providence Hood & Portland to Coast relay race. Approximate total retail value (“ARV”) of prize is \$2,483. Prize has no redeemable cash value; any difference between the stated value and the actual value at time of award will not be provided. No substitutions allowed, except that prize is subject to availability and Sponsor reserves the right to substitute a prize of equal or greater value. Winner agrees that the prize awarded is personal to such winner and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated, or otherwise conveyed, without the express written consent of Sponsor. Winner (and selected team) must be able to attend the above noted relay race (“Race”), no refund or credit will be provided to winner if such person is unable to attend the Race specified for any reason.

The odds of winning the prize will depend on the number of eligible entries received during the Entry Period. There is one (1) prize available for award in this Sweepstakes.
- 5. WINNER NOTIFICATION AND ACCEPTANCE.** The potential winner will be notified by email as provided on the entry form within seventy-two (72) hours of the drawing. In the event contact with a potential winner is not confirmed within three (3) business days of attempted notification, or if a potential winner declines to receive the prize, another entrant will be randomly chosen. The confirmed winner, and not the team, is solely responsible for any and all federal, state, and local income taxes, and unless specifically stated herein, is solely responsible for any additional expenses which may be associated with participation in the Sweepstakes, and acceptance and/or use of the prize, including but not limited to hardware, software or any other technical requirements for use of prize.
- 6. PRIZE CONDITIONS. Prize consists of a single team entry into the Race and does not include transportation, lodging, or anything other than Race entry.** Sponsor is not responsible for and will not pay or in any way compensate the winner for travel, equipment, taxes, or any costs or expenses associated with participation in and/or acceptance or use of the prize in this Sweepstakes. As required by law, in the event the prize exceeds \$600, Sponsor will issue a Form 1099-MISC to the tax identification number associated with the winner (not the team selected by winner) to whom the prize was awarded winner reporting the taxable retail value of the prize at the time of award. The potential winner should consult a professional tax advisor about the tax implications of winning and accepting

the prize. The potential winner agrees to execute all necessary and requested documents, including without limitation a declaration of eligibility, and a liability and publicity release (except where prohibited by law), as requested by Sponsor, and may be required to provide a copy of a government issued identification card containing a photo of such potential winner and a valid social security number. Failure by the potential winner to sign and return the required documents, or to comply with any term or condition of these Official Rules, may, at the sole discretion of Sponsor, result in disqualification and forfeiture of such winner's interest in the prize..

- 6. ASSUMPTION OF THE RISK.** Winner assumes all risks associated with the Prize. Winner acknowledges that the prize is a team entry into a physical race and the course does or may consist of potentially dangerous terrain and/or extreme weather conditions, and that use of the prize could result in, but not be limited to, physical injury, death, property damage, or emotional distress. The participant understands that running on dangerous terrain can lead to strains, sprains, fractures, hypothermia, dehydration, heatstroke, and other serious medical conditions. By accepting the prize, the Winner assumes all responsibilities for injuries and death, and on behalf of themselves, their heirs, assigns, personal representatives, and estate, hereby releases and forever discharges Sponsor (and "Released Parties") from any and all liability, claims, demands, losses, or damages arising out of or in any way connected with use of the prize.
- 7. PARTICIPATION.** By entering the Sweepstakes, each participant agrees to follow and be bound by these Official Rules and the decisions of Sponsor and hold harmless and indemnify First Tech, Administrator and each of their respective parents, subsidiaries, affiliates, directors, officers, employees ("Releasees") and agents against any and all liability, damages or causes of action (however named or described), with respect to or arising out of either entrant's participation, or (ii) the receipt or use of the prize, or any portion thereof, awarded in the Sweepstakes. Sponsor reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Sweepstakes as solely determined by Sponsor. In the event the Sweepstakes is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of Sponsor which corrupts or impairs the administration, security, fairness or proper operation of the Sweepstakes, Sponsor reserves the right in its sole discretion to suspend, modify or terminate the Sweepstakes. Should the Sweepstakes be terminated prior to the stated expiration date, Sponsor reserves the right to award prizes based on the entries received before the termination date.

Except where prohibited, participation in the Sweepstakes, including acceptance and use of the prize, constitutes entrant's consent to the publication, dissemination and use of such person's name, photograph, image, likeness and voice, if applicable, by Sponsor, at any time, for any purpose, without any additional compensation to, permission from or inspection by such entrant.

- 8. CHOICE OF LAW.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of any entrant and Sponsor, shall be governed by, and construed in accordance with the laws of the State of Oregon, without giving effect to any choice of law or conflict of law rules or provisions (whether of Oregon, or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than Oregon. The invalidity or unenforceability of any provision of these rules shall not affect the invalidity or unenforceability of any other provision. In the event that any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.
- 9. USE OF DATA; PRIVACY.** Except where prohibited, participation in the Sweepstakes constitutes an entrant's consent to Sponsor's use of his/her name, likeness, voice, opinions, biographical information, and state of residence for promotional purposes in any media without further payment or consideration. Any personally identifiable information collected during an entrant's participation in this Sweepstakes will be collected by Sponsor and used by Sponsor and its respective parent companies, subsidiaries, affiliates, agents and marketers for purposes of the proper administration and fulfillment of the Sweepstakes as described in these Rules. By entering any Specific Promotion, Entrants agree to receive future marketing communications from Sponsor regarding promotional offers and product information. Sponsor uses commercially reasonable efforts to comply with CAN-SPAM guidelines. Entrant may subsequently opt out of receiving further communications by following the instructions contained in the email communication. Sponsor will not sell or rent entrant information, and Entrant may opt out of receiving commercial emails prior to the end of the Sweepstakes.
